RESOLUTION 199 (IX)

WORKING CAPITAL FUND

Report of the Committee on Contributions
and Budgetary Matters

The General Conference,

Bearing in mind Resolutions 6 (I), in which the Working Capital Fund was established and 64 (III), in which the proportion of 10 per cent of the General Fund was fixed as the amount of the Working Capital Fund;

Recalling that the budget for the 1984-1985 Working Capital Fund was \$US 48,372.00 and the budget for the 1986-1987 biennium increased to \$US 50,810.20 and that the difference between the two is \$US 2,446.80;

Having considered document CG/277 submitted by the Committee on Contributions and Budgetary Matters,

Resolves:

1. That for the 1986-1987 financial period, the Working Capital Fund shall increase by \$US 2,446.80, so that the Working Capital Fund will be equal to 10 per cent of the General Fund for the same biennium.

2. That the amount mentioned in the above paragraph shall be covered in accordance with the apportionment assigned to the States according to the Scale established by the General Conference for the financial period in question, Resolution 198 (IX).
